



PEI grants are central to PEI influence model and country engagement efforts. To date, 20 grant awards to government-led programs have been provided, devised to leverage national programs, World Bank financing and global expertise.

This is the case for both the Northern Uganda Social Action Fund (NUSAF) and the Ministry of Social Development program "Cohesión Social" in Panama.

The two programs have been featured in leading news outlets, underscoring the role of Social Protection and Economic Inclusion in national development strategies and the success of the Cash Plus approach to overcome inequalities faced by the indigenous peoples.


